GENERAL ELECTION

Provisional Ballots:

- Randall Denton and Loretta J. Denton – Voters were allowed to vote provisionally at German Twp. Vote Center as Johnson County Voter Registration had registered them in error in Johnson County. The voters live on the Bartholomew/Johnson County line. The Election Board unanimously agreed to add the votes to the final count on Election night.
- James Hagan – Voter did not produce identification at the vote center. Voter must produce identification to the Voter Registration Office in order to be counted.
- Linda Cadle – Voter was not registered and did not produce Indiana issued identification at vote center. Voter insisted she wanted to vote by provisional ballot. The Election Board unanimously voted not to count the vote.
- Eric Whitaker – Voter said he had completed a registration form in the 2016 Primary, but no record could be found by the Voter Registration Office. Voter did a registration form and then voted provisionally. The Election board unanimously voted not to count the vote.
