The Bartholomew County Council met on September 8, 2020 at 6:00 p.m. in the IT Conference Room of the Governmental Office Building, 440 Third Street, Columbus, Indiana.

President Miller called the meeting to order.

Bill Lentz gave the Invocation and led the Pledge of Allegiance.

The first item on the agenda was the approval of the meeting minutes for the following meetings: July 14, August 11, August 17, August 18, August 19 and August 20, 2020. Laura DeDomenic made a motion to approve the minutes as presented. R Scott Bonnell seconded the motion which passed unanimously.

The next item on the agenda was a Request of Additional Appropriations in County General – Coroner's Office (1000-07) in the amount of \$46,250.00. Coroner Clayton Nolting stated this would get his office through the end of the year. Numbers this year have been very high. They have 25 confirmed and 1 pending overdoses. They have had 4 homicides and several suicides. The autopsy expenses are what are causing them to run short. For accidents, they do toxicology and X-rays to make accurate cause of death determinations. Due to the sheer numbers, he will also be short in funding for his contract employees. Mark Gorbett asked for a breakdown. The biggest portion is \$35,000 for autopsies. Mark E Gorbett made a motion to approve the request for \$46,250 as presented. Jorge R Morales seconded the motion. Bill Lentz asked how he came up with the numbers. Coroner Nolting stated that as of yesterday they were at 126 cases this year and last year they did not reach 126 until late December. There are some cases that, by law, require autopsies but he does have the power to call for an autopsy on the remaining cases. They have started autopsying all overdoses cases as they had one that was classified as an overdose but an autopsy showed very little amounts of drugs in the person's system. Since then, unless it is just extremely clear that it was drugs, he is having an autopsy completed. Jorge R Morales asked how confident he felt about his 2021 Budget that he had submitted. Coroner Nolting stated he did add to the budget for 2021 so he is good with it. He stated that his business is just so unpredictable. **The vote was called for and passed unanimously.**

INDOT has finally sent the check for the CCM Grant so the money is in the fund. The majority of the work has been completed. He is asking for this to be appropriated so he can pay for the completed work. Any overruns of the project will be the County's to pay. This project was for over 18 miles of overlay. The total of the funds, \$210,000 would be placed in LRS Road Equipment (1169-04-04-91). This is left over funding from salt purchasing and infrastructures. They wish to purchase a new dump truck. Bill Lentz asked what they use to determine when to replace a truck. Engineer Hollander stated the one they are replacing has been having a lot of trouble with the emission control system. Jorge R Morales asked how many miles they put on their trucks before replacing them. Engineer Hollander stated that it is determined by maintenance needs and rust due to hauling salt all winter, not so much on mileage. The amount of the transfer should cover the truck with a snowplow, sandbox and radio. Mark E Gorbett made a motion to approve the request for \$210,000 as presented. R Scott Bonnell seconded the motion which passed unanimously.
